Meeting was called to order by President Erika.

Copies of the minutes from the reorganizational meeting on December 14, 2012 were read by Erika. A motion by JR and second by Chris to approve. Motion Carried.

Kim passed out copies of the minutes from the annual meeting for the board to look at for any corrections or additions.

Advertising – Kim told board about the info she had received from 3 radio salesman. Claye then made an amendment to the motion to add that the NDSA would pay for the broadcasting of the sale for this year and Kevin 2<sup>nd</sup>. Motion with amendment carried. Jeff will make arrangements with Kist Livestock and Auctioneer. Kim will make arrangements with the Ramkota Hotel.

Correspondence was received. A thank you from Kylee Myers was read. A letter of complaint was read from a consignor from the 2012 state sale. Board will respond with a letter.

Board reviewed secretary/treasurers performance. A motion to give Bob Grant \$500 worth of gift certificates to the Ramkota Hotel was made by Kevin and Cody 2<sup>nd</sup>. Motion carried.

Committee assignments were went through.

Bob presented the financial report. Cash flow sheets, settlement papers used for sale results, and other papers detailing income and expenses were passed out. Bob went through the sheets, board reviewed and discussed. Bank balance as of 12-31-2012 - \$, CD's - \$, cash box - \$65. Other items covered: 154 meals were served at the banquet, semen auction - \$3910 and donation heifer - \$13,245

Audit report was looked at by Erika and Kevin

ND/SD Simmental magazine was given by Erika. She would like to move the deadlines earlier for the issues. She wanted to be able to make sure that issues were mailed in time for the advertisers to benefit the most.

Annual Meeting/Banquet was discussed. Luke had a suggestion for this year's speaker to be someone from the State Animal Board of Health to talk about Johnes testing in cattle and why it is becoming more important to learn about this disease.

Jr Simmental report- It was brought to the boards attention that they owe the ND Jr Simmental Assoc. \$500.00 for sponsoring a meal at the North Central Simmental Regional in Huron, SD in June of 2012.

Feeder Calf Sales – Luke went to both sales at Kist and Napoleon. He would like to move the sales away from the new years holiday. A motion was made by JR to move the simm-influence feeder calf sales at Kist and Napoleon to the 2<sup>nd</sup> Wednesday and the 2<sup>nd</sup> Thursday in January and Luke 2<sup>nd</sup>. Motion carried.

Futurity discussion – It was decided to leave as is, paying cash 5 places;  $1^{st}$  - \$600,  $2^{nd}$  - \$500,  $3^{rd}$  - \$400,  $4^{th}$  - \$300 and  $5^{th}$  - \$200

Membership – Kim will mail reminder postcards in February. Board decided that if someone wishes to have our membership list then mail them a directory.

The board approved the sponsoring of the same events as last year; ND Junior Beef Expo, North Star Classic, Stockmens tour, Little I and NDJPSA.
