Board members present: Claye Kaelberer, Chris Nicholson, Luke Keller, Kevin Elliott, Cody Hanson, Tyler Kinn and Erika Kenner. Sec/Tres. Kim Myers was also present.

Meeting was called to order by President Erika Kenner.

Motion to accept the agenda was made by Cody and Claye 2nd. Motion carried.

The minutes from April were presented and an amendment was made. Chris made the amendment to show the increase to the directory advertising rates of \$500 for a whole page ad and \$300 for a $\frac{1}{2}$ page ad that was made by conference call and Kevin 2nd. Amendment carried. Kevin made a motion to approve the minutes as amended and Tyler 2nd. Motion carried.

Kim passed out financial statements. Board reviewed and discussed some of the items on the statement. Bank balance as of Aug 13 was \$23,581.61. Motion by Kevin to accept the treasurer's report was made and Tyler 2nd. Motion carried.

Annual Meeting: Motion by Luke, 2nd by Cody to recommend to the membership that the by-laws include term limits of 2 years each for the Director offices of President and Vice-President. One no vote from Chris and Kevin abstained from voting. Motion carried. (This change will need to be voted on at the annual meeting). Annual meeting will be at Kist Livestock Friday, December 27, 2013 at 12:00 (noon). Lunch will be served at 11:00 am. Agenda will be similar to last year. Board members will give

reports. The nominating committee of Mike Johnson, Chris Nicholson and Erika Kenner will find candidates to fill one (1) at large position and one (1) east position.
