Board members present: JR Aufforth, Chris Nicholson, Cody Hanson, Claye Kaelberer, Tyler Kinn, Kevin Elliott and Todd Finke. Kim Myers was also present.

Meeting was called to order by President JR Aufforth.

Additions to the minutes were added as clerking to the showcase/classic sale discussion. A motion to approve the agenda with the addition added was made by Claye and Tyler 2nd. Motion carried.

Minutes from the April meeting were presented and a motion to approve was made by Claye and Todd 2nd. Motion carried.

Financial report was given by Kim. Checkbook balance is \$21,399.70 and the balance in the Edward Jones account is \$12,166.78. A motion to approve the financial report was made by Todd and Chris 2nd. Motion carried.

Kim updated the board on what some of the jr members have been busy with. 3 families exhibited at the Western Regional in Bozeman in June, 37 jr members exhibited at the state fair. The futurity show was successful that was held with the jr Simmental show on Tuesday of the fair.

The feeder calf sale dates will be Jan. 8 at Napoleon and Jan. 14 at Kist.

The scholarship committee has add the addition of allowing college freshman to apply for the annual \$500 scholarship. The scholarship application will be printed in upcoming issues of the Scene as pages allow. Deadline will remain as March 15, 2015.

Registration papers on the sale cattle was discussed. A motion to have consignors bring the registration papers with the breeding info filled out with ASA registration numbers for sires used on the papers for the bred heifers was made by Kevin and Claye 2nd. Motion carried.

Erika was put on speaker phone to give an ASA update. Meetings had just concluded in Bozeman. The fall meetings are going to move around the country. An application will need to be submitted by the State Association that wishes to host. This year in Denver the board members will be present in the yards.
